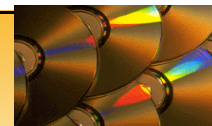

## ***Tech Writer Spotlight: Erin Witkowski***

*The technical communicators of the Orlando Chapter STC have wide varieties of specialties, skills, and careers. This new column will introduce us to a different member every month and answer some questions about his or her job and industry.*

**Erin Witkowski** is a technical proposal writer with Priority Healthcare. She has worked as a technical writer for three years and has been with Priority Healthcare for one and a half years. She earned her BA in English-Technical Writing from UCF in 2002. Erin has been an STC member for two and a half years.

### **Q. Can you provide a brief summary of your position?**

I am the resource to the sales force: before the sale, writing the presentations for the sales directors to deliver, then answering the resulting RFP (request for proposal), then preparing the finalist and site visit presentations for executive management to deliver, answering any follow up requests from the client prior to signing a contract.

Then, following the contracting phase, I am involved in writing communications materials for their clients (patients and physicians) to effectively market the product they have purchased from us. Later in the relationship, I support the sales directors and account managers with communicating clinical and operational savings opportunities at quarterly meetings. Many times these meetings require a "state of the union" type of paper that describes where they are and where opportunities for enhancing their program exist.

### **Q. What kind of documentation do you write?**

I write proposals, presentations, white papers, external communications copy (e.g.; brochures,

letters, FAQs), fact sheets, booklets, and Web copy.

### **Q. What software do you use?**

I use Word, PowerPoint, Excel, Visio, PhotoShop, Adobe Professional, and Microsoft Project.

### **Q. Who do you report to? Who do you have to interact with in developing products (Engineers, HR, etc.)?**

I report to the Senior Vice President of Managed Care Sales & Government Programs. I typically interact with senior management—clinical, operations, IT, payor implementation, account management, customer service, finance, etc.

### **Q. Does Priority Healthcare employ other technical writers?**

I am the only technical writer in the company (a company of over 1400 employees). I do have support personnel available to aid with the copious amount of work; however, I am ultimately responsible for the end product.

### **Q. What do you feel is unique about being a technical writer in your industry?**

Well, for one thing, they had posted my job for about a year before I put my resume on Monster—and they contacted me immediately. That says that there are not too many tech writers with healthcare experience in the marketplace. I think that before a company (other than the old standbys like the IT or military-based industries that have long recognized the need for TWs) hires a tech writer, they don't realize how much they need someone with this kind of background and expertise. Now, I know that my place here at the company is recognized as invaluable. In fact, we are going to expand the department within the next year to include

## Tool Tips: Dual Monitors

A few months ago I began using a dual-monitor setup on my office PC. I asked for this setup because I was using FrameMaker in structured mode and the floating palettes obscured the documents I was working on. I could have addressed this problem by using a bigger monitor and stashing all the floating windows off to one side, but I tried this using a 19" CRT monitor, and it was still a bit difficult. If you have tried both, I think you will agree that the dual monitor setup works better.

In order to use two monitors, you have to have an operating system that supports it, such as Windows 98 or later, and a video card that supports two monitors. I understand that you can install two PCI slot video cards and get the dual monitors to work, but I haven't tried it.

My setup is Windows 2000 with a Geforce 5200 F/X video card. With the Dell Optiplex I am using, both monitors have to be plugged into the video card and the onboard video must be disabled. Quite honestly, it was difficult getting it set up, but I am fortunate to have great technical support people at my job, and they helped me get it up and running.

One of the first things I noticed about the dual-monitor setup was that the second monitor did not have a taskbar. I use my taskbar a lot because I usually have four or more applications running at one time and the taskbar allows me to switch between running applications.

Roman Voska, aka Oscar, offers us a choice of taskbar or no taskbar on our second (or third) monitor. If you visit his Web site, <http://www.mediachance.com>, you can download Oscar's Multi-Monitor TaskBar. Like most of the tools I have presented to you, this one is also free. Just download the ~500 KB executable and run it. The software installs and starts working right away.

The Oscar web site says that in order to use his software, the secondary monitor must be on the right and the monitors must have the same resolution. Also, the Oscar application does not work with Windows 95, 98, or ME. If you are using three monitors, the primary monitor must be the one in the middle. Since none of these limitations applied to me, I installed the program and was running in a couple of minutes.

The Oscar application is simple and I love it. The applications you have running on the second monitor only show up on that monitor. I like to display Acrobat files on my second monitor and FrameMaker files that I am comparing them with on my first monitor. The Acrobat icon

displays only on the second monitor's taskbar. I like having the time show on that monitor, too.

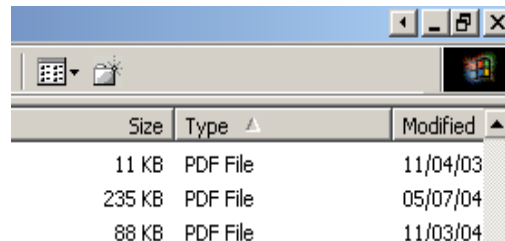


Figure 1: Windows Explorer with the Move to Monitor button

TaskBar adds a "Move to Monitor" button to your applications as shown below in Figure 1. Just click the button and your application moves to the other monitor. If you have three monitors, then TaskBar adds two buttons to your application's titlebars.

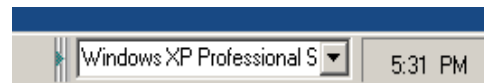


Figure 2: The Text Clipboard Extender

A second feature of the TaskBar is the Text Clipboard Extender on the TaskBar, shown below in Figure 2. The

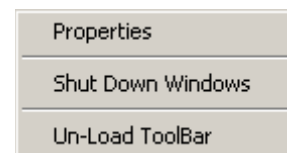


Figure 3: The Taskbar pop-up menu

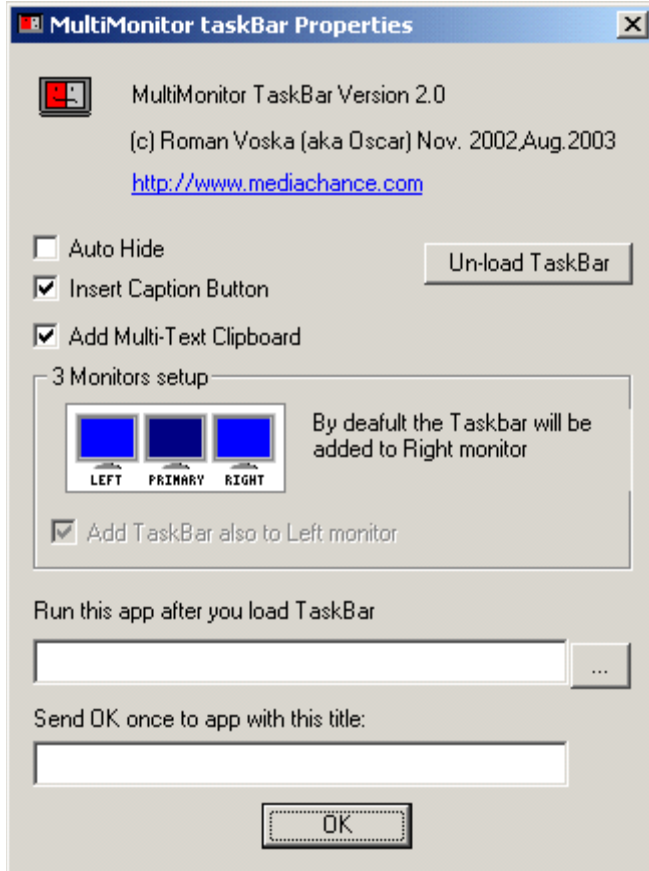


Figure 4: The Taskbar properties sheet

Extender captures and stores the last 100 text copy operations and lets you select any of the text entries and paste them into a document. Simply click the drop-down arrow, and double-click an entry to paste it into a document. When you right-click the TaskBar, a pop-up menu displays (Figure 3) with three choices: Properties, Shut Down Windows, and Unload Toolbar. Choosing Properties brings up the Properties sheet (Figure 4) where you can set your options. Choosing Un-Load Toolbar removes the TaskBar from the second monitor. You can unload it and reload it without having to restart the computer. The Shut Down Windows command did not do anything on my PC, but that is a small bug I can live with.

The Auto Hide checkbox performs the same auto hide function as is available on your regular taskbar. The Insert

Caption Button checkbox lets you display or hide the Move to Monitor buttons on your applications. The Add Multi-Text Clipboard option displays or hides the Text Clipboard Extender on the Taskbar. Be sure to read Oscar's Web pages for more information on how to use this great tool. He has a number of other applications you may want to check out also. **MtM**

## If You Missed Our Last Meeting. . .

If you missed the December meeting, then you missed a dynamic presentation by one of STC-Orlando's favorite guest speakers, Patrick Koster. Patrick is President of Koster Associates, which provides customized Adobe training solutions nationwide, and as he has amply demonstrated in previous visits, he incorporates a wealth of valuable information about Adobe products into every presentation. Incidentally, there is no truth to the rumor that Patrick's popularity as a speaker stems from his habit of giving away a copy of Acrobat Professional as a door prize at every meeting.

At December's meeting, Patrick previewed Adobe Acrobat Professional version 7.0. Although version 7.0 has been launched, it was not yet shipping at the time of December's meeting. Patrick advised Orlando chapter members that version 7.0 will allow the creation of profiles that will enable or disable certain functionality, thereby allowing users great flexibility in the way their PDF documents are delivered, read, and stored. Version 7.0 will also provide enhanced functionality in the free Adobe Reader, which will allow recipients of PDF documents to add and save comments, and will permit users to save information they have entered on forms. After previewing version 7.0, Patrick then proceeded with a detailed dissection of Acrobat Professional version 6.0. Among other things, we learned that version 6.0:

- allows users considerable editing capability through the use of the Select Text tool
- provides the Layers tab as a convenient way to add or delete information
- contains dynamic Zoom and Loupe tools
- is particularly well-suited for forms development work
- easily creates bookmarks for all kinds of documents

Patrick demonstrated an expedited process to simplify the electronic review of a document, and showed an example in which a Web-based review process allows simultaneous, real-time review of documents by multiple reviewers. Cool stuff.

In other happenings at December's meeting, Dr. Melody Bowden, Assistant Professor of English at the University of Central Florida introduced her guest Dr. Ian Gibson. Dr. Gibson is a Visiting Assistant Professor in UCF's Division of Digital Media, and will be the guest speaker at the January meeting of STC to be held at UCF on January 25<sup>th</sup>. Jen Selix, President of Future Technical Communicators (FTC), a student-run organization at UCF, outlined plans for the upcoming spring series of free workshops FTC offers each month at UCF's Technical Writing lab. WC Wiese delivered an update on the judging for the Gloria Jaffe Technical Communication Excellence Award, and crowed about the strong meeting attendance the Orlando chapter has experienced

## Spreading the Word: 2005 High School Writing Competition

Orlando chapter members returned to school last fall – high school, that is.

To promote the Ninth Annual Central Florida High School Technical Writing Competition, seven members challenged high school students to think about technical communication as a career. These enthusiastic speakers used chapter-created presentations and handouts, as well as items from their own portfolios, to show students the exciting range of communication products that we create.

### First-Timer Falcons Fly into the Competition

Barbara Odom kicked off the promotion. In early October, she met Ed Santsaver's students at the Advanced Technology Center (ATC) of Daytona Beach Community College. Barbara was pleased with her session, calling the ATC "a gorgeous school, a combination of a charter school for high school kids and a vocational technical institute for post-high school."



Ed, as you remember from earlier *MtM* articles, struggled to keep his classes going after three hurricane-force disruptions. Chapter members pitched in with donated books to replace those Ed lost in the storms. Our efforts clearly touched Ed and his students. When Jen Selix and Gail Lippincott spoke to two of Ed's classes in mid-December, these advanced placement high school students were turning in their nicely illustrated technical reports. Jen and Gail explained the Competition's guidelines and encouraged students to revise their papers after Mr. Santsaver graded them. With a January 15 deadline, students have time to create top-notch entries.

### Patriots Prepare for Clean Sweep

Competition chair Jon Kessler is a veteran presenter who usually covers Winter Springs High School. The hurricanes, however, disrupted all kinds of schedules, and Jon instead spoke to Dr. Suzy Behel's classes at Lake Brantley High School where Dan Jones usually presents. Jon invited Gail Lippincott to come along, and their presentation was fun and interactive. Students were very interested in the Competition guidelines, asking lots of questions about how to incorporate graphics and formatting. Look out for another bumper crop of excellent papers from Winter Springs!



### New Challengers: Crooms Panthers Wired for Success

The on-the-job training with Jon encouraged Gail to speak to three

classes at Crooms Academy of Information Technology in Sanford. This new magnet school for Seminole County provides its students with laptops and wired classrooms, letting Gail show students the chapter Web site, competition guidelines, and samples of papers and good entry forms. Most students had never heard of technical communication, and no one had thought about any audience other than the teacher for their required reports. Faces lit up when Gail asked how a "simple" explanation by one student of how to send a text message on the cell phone would need to be revised for someone who had never used a cell phone. This ability to understand the needs of different audiences underscored the value of technical communication in any job. We look forward to cultivating a strong relationship with Crooms teachers and students and many excellent entries for this year's Competition.



### Returning Panthers Break in New Speaker

Several other chapter members wanted to know how to conduct these high school presentations, so Jon held an informal teach-in after the October chapter meeting. Pumped up by this guidance, Allison Johnson took on Dr. Phillips High School, taking over Mike Murray's usual venue. Allison looked over the materials Jon and Mike had given her, prepared an outline, and consulted with her contact, teacher Mary Ann Revel. Allison described her successful presentation to four senior English classes:

"I enjoyed getting off at 2:15 after a 'full day' of work. I enjoyed taking a vacation day from my real job to do the presentations. I very much enjoyed going through my portfolio and talking about my experiences because it reminded me what a full and rich life I've had as a technical communicator. I also enjoyed encouraging these students to enter the contest (they had already done their research papers, so it was really just convincing them to send in the papers). I wasn't sure when I left how many (if any) students would enter, but I did have a good feeling that at least they heard something about the field and a potential career they may not have realized was out there."



### Blue Darters Armed for Victory

The Dynamic Duo of Bonnie Spivey and Dan Voss enjoyed another successful visit to Apopka High School's advanced senior engineering students. Dan explained that "the science teacher, Ken Bowles, made it clear to the class that this was an assignment for a grade. And English teacher Melissa Reicker, an STC member with 10 years of experience as a tech writer, has agreed to review the assignments for syntax, grammar, and mechanics (Ken will review them for content expertise). Melissa attended our session and jumped right in

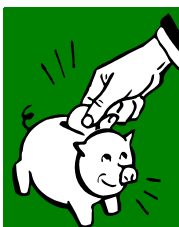

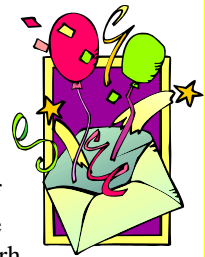

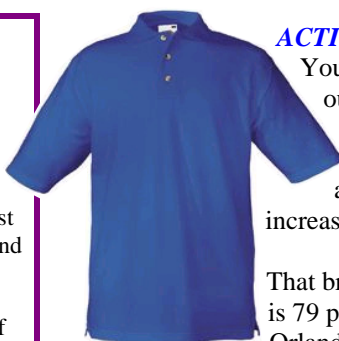
## FROM THE EDITOR'S DESK

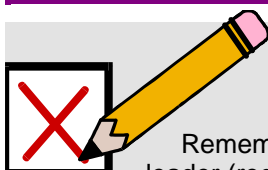
## ACTIVE MEMBERSHIP CORNER
